- You must first create a Tourist Development Tax account online for the short term rental property listed on this application. Please visit <u>www.pbctax.com/tdt</u> to create an account.
- This BTR cannot be transferred. It is only valid for the short term rental property and TDT account number listed on this application.
- If you own more than one short term rental property, you must have a Tourist Development Tax account and BTR for each property.
- This type of BTR (for short term rental) does not require zoning approval.
- You must renew this BTR annually by Sep. 30 to continue offering the property listed below for short term rental.
