# SUBJECT: REGISTRATION OF VEHICLE WITH OUT-OF-STATE TITLE WITH LIEN

## PLEASE FOLLOW ONE OF THE FOLLOWING TWO PROCESSES.

**PROCESS 1)** Privately owned vehicles - Our office is assisting the individual(s) named in Section 1 of this form with registering a vehicle in Florida. The individual(s) indicated you are the lienholder. To register a vehicle in Florida, we require the individual(s) to apply for a Florida title at the time of registration or to produce proof that the title is held by an out-of-state lienholder.

**Option A:** Mail the title to the address in Section 2. The vehicle will be registered and titled in Florida showing your institution as lienholder. We prefer you follow this method. NOTE: If you release the title, in accordance with Florida statutes, the Department of Highway Safety and Motor Vehicles requires titles with liens held electronically. This means Florida's Electronic Lien and Title (ELT) program requires mandatory participation from lenders. **Provide a copy of this letter with the title when mailing. In addition. if mailing via USPS. FedEx. etc.. provide your client with a tracking number to confirm receipt of the title.** 

**Option B:** If you do not release the title, you must send our office a copy of this letter, <u>a letter on your</u> <u>letterhead indicating there is an outstanding lien on the described vehicle (include the year, make and vehicle identification number)</u> **AND** a copy of the title (front and back)

**Option C:** The out-state certificate of title is electronic. In this case, the letter on letterhead stationery from the lienholder must state that. An email copy is acceptable. Please enter "**Out of State Title**" in the subject line when emailing. <u>Provide a copy of this letter with the title when emailing.</u>

**PROCESS 2)** Leased vehicles - Submit your Florida Sales Tax Exemption Number, a copy of the lease agreement and an original Power of Attorney allowing the lessee to sign the required documentation. <u>Provide a copy of this</u> <u>letter with the title when mailing. In addition, if mailing via USPS, FedEx, etc., provide your client with a</u> <u>tracking number to confirm receipt of the title.</u>
